WHAT DOES ALIGN IMPACT, LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:
	■ Social Security number, assets, income, risk tolerance, account balances, transaction history.
	■ Information we receive from you and from other professionals who provide services to you on
	applications and forms, through communications and from consumer reporting agencies.
	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Align Impact, LLC chooses to share; and whether you can limit this sharing.

What we do How does protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
